9. NEW BUSINESS

- A. Draft Warrant: The Draft is being prepared to be voted upon at the local election on November 8, 2022. The issues are the Town government disposition from the open Town meeting to the closed ballot format, the change of the Select Board from a three member board to a five member board, and the approval of \$100,000 transfer from one account to another for LED lighting for the School. There will be a Public Hearing on October 5, 2022. The Warrant and Finance will meet on September 26, 2022 at 6 p.m. The Public hearing will be on October 5, 2022 and absentee ballots will be available on October 7, 2022.
- B. Appointment: To appoint Mike Demers as Deputy Code Officer on an as needed position. The salary would be \$35.00 per hour, without benefits. Tom McGurty felt this was a reasonable rate of pay.
