D. Facility Assessment Update

Mike Harwood came to thoroughly inspect the Town facilities including the old Fire Station and Municipal Complex last week. Pictures, measurements were taken, files were reviewed; and Mr. Harwood indicated it will be about 2 weeks before he released his recommendation and ideas for the Board to review. Some thoughts include the Fire Station being refurbished and utilized; town hall facilities structurally sound but needs attention in the interior; kitchen; entrance way and parking lot. Discussion ensued regarding processes related to projects and budgeting highlighting the need for public thoughts and input; possible public hearing.

## E. 2023-2024 Budget

The Town Administrator presented the Select Board with a packet that covered the entire budget to be used to review and as a tool for meeting with Warrant & Finance on Monday. The Select Board asked for base budget costs before special projects. The Town Administrator will provide in the next day or two. The Select Board is scheduled to meet with Warrant & Finance on Monday to review the Municipal Management budget line by line. Road Commissioners budgets were looked at and discussed. The Road Commissioners will need to meet with the Select Board or have a Workshop to bring it together.
