2. TOWN ADMINISTRATOR WEEKLY UPDATE

The Town Administrator updated the Board on the following information:

- · Special Election next week for a new Selectmen Town Administrator is happy to have this election complete so that items pending can be attended to; item include:
 - · Transfer Station Position Hiring
 - · Town Administrative Assistant Hiring

These positions need to be filled as the Town is short staffed.

- · Executive Sessions will be held next week with the new Selectmen to review these items.
- The Acton Shapleigh Youth Corp submitted a copy of their annual report.
- · Review of Ballot Clerks by the Board to make sure there were no issues.

The Board had no concerns

- Public notice that the Acton Planning Board has scheduled a public hearing for Thursday, December 16, 2021 to discuss the Conditional Use for Seth McCoy Trucking and Excavating, Map/Lot 207-001. Site walk is scheduled for December 11, 2021.
- Foreclosure notices are going out next week. There are 45 days to pay taxes before the Town takes ownership. There are 15 names on the list.

- · Update on meeting with Acton Selectmen, Shapleigh Selectmen, York County Sheriff's Department and the County Manager regarding the contracted deputy's promotion. Outcome: Job is posted in-house for 2 weeks. Individuals interested will be interviewed by both towns. The new incoming Deputy tier being paid will be higher than Deputy Sevigny's scale. The Treasurer indicated timing may allow for little bit of a buffer towards the estimate of 12,000 14,000 difference

per town in what could be the pay scale. One of two things can happen: 1) The Town can agree to dissolve the contract and what is not spent can go back into the general fund or 2) the Town can vote to come up with the difference in monies to maintain the contract through November of 2022. However, what will probably happen in November of 2022 is that the York County Department will dissolve the Contract Deputy program as there are no enough Deputies to cover all the open positions. Not what was intended and not what is final but, it is a preliminary look of how it is. Currently the bills are being prorated; the 14-day contract change notice was given. We still have coverage, it is just not a dedicated Deputy.
