

**TOWN OF ACTON
SELECTMEN'S MEETING
JULY 18, 2006**

1. PUBLIC FORUM: Richard Michaud complained that his wife took a mattress and box spring to the Transfer Station and attendant Brian McGlincey would not allow her to leave it because it was not broken down into components. This greatly inconvenienced her. Transfer station manager Steve Ledoux noted that they require owners to have all products separated. If a person is not physically capable, the attendants will break it down for them. Ledoux's understanding of the situation was that Brian unloaded and accepted everything she had on her truck except the mattresses.
