1. **APPROVAL OF AGENDA:** Bill Shields made a motion to approve the agenda; seconded by Ed Walsh, all in favor, motion carried.
2. **APPROVAL OF MINUTES OF LAST MEETING:** Bill Shields made a motion to approve the minutes from April 30, 2015; seconded by Ed Walsh, all in favor, motion carried.
3. **OLD BUSINESS:**
 - a. **Sand/Salt Shed Bid**
