 - **1. BEAVER PROBLEMS:** Bill Shields reported Wilson Lake citizens have reported problems with beaver dams blocking the Wilson Lake to Horn Pond outlet and plugging the culvert. Selectmen have contacted the State biologist who informed them that it is illegal to destroy a beaver dam. A licensed trapper must be contacted to trap the beaver.

 - **3. Larissa read the following winter snow plowing policy: Public health and safety deem it necessary that the Road Commissioners and their crews keep the roads clear of snow to the outside edges of the shoulders of the roads, therefore it is of the utmost importance that all plowed rights of way within the Town of Acton remain clear of obstruction. It is the obligation of all owners and occupants of property within the Town of Acton to assure that no mailboxes, paper boxes, signs or similar structures obstruct plowed rights of way. Any such structures within a right of way exist there at the risk of the owner. Neither the Town of Acton nor the road crews are responsible for damage caused to the structures by the plow.
