 - 1. ACCEPTANCE OF ROBIN HAM'S PROPOSAL FOR MOWING TOWN HALL, PUBLIC SAFETY BUILDING, MARY GRANT NATURE PRESERVE, LINCOLN SCHOOL FOR \$3,500.00 MAY THRU SEPT: On a motion by Dennis it was voted to accept Robin's proposal.
 - **2. KEN PAUL RE: LEBANON ROAD FEES:** Ken explained that building construction was done on Lebanon Road with no permits. The home owner was told by the builder that he had all necessary permits which was untrue. All construction except some electrical and plumbing has been removed for inspection and the septic has been photographed. Acton's ordinance calls for 4x the fees for building without a permit but because of the hardship and the fact the owners were lied to, Ken is willing to waive some of the fee. He is willing to settle for \$1,682.40. On a motion by Dennis, the fee will be reduced to \$1,682.40.
