A. Skid Steer Bids

The Town Administrator recapped the bid numbers:

B. Brush/Chipping Bids

- Hawkes' is a big company who has been in business for over 20 years with 25 employees. They handle several Transfer Stations including Phippsburg and can do the work in about 3 weeks . A link of bid details was sent to the Select Board to review; presentation was very professional.
- JA Simpson has also provided liability insurance and workers compensation and can do work by 12/31/24.
- Confirmed low bid was to grind, remove brush and chips from Transfer Station; contaminants would be left behind.

Walsh made a motion to award the Brush/Chipping bid to Hawkes' Tree Service for \$10,000; Norwood seconded. All in favor. Motion carried.

9. NEW BUSINESS

A. Sand Bid

The Town Administrator reported that the Road Commissiner asked for the Sand bid to be put on the agenda. The Sand Bid is similar to last year's bid stating the Town of Acton is soliciting bids for upto 3,000 yards of 3/8 " screened winter sand. Return bids by Wednesday, September 25, 2024. Bid asks for the amount per yard to be delivered to 890 Sanborn Road (Up to 3,000 yards and asks if bidding company has normal year round business hours outside of routine weekends and holidays. This will be sent out for a few weeks.
